11-	Shall <b>Exhibit</b> list of nomination papers giving name of candidate, proposer and seconder <b>after proper scrutiny by Election Commission</b> on notice Board-Website and to D.G/T.O.	=	<u>26-08-2011</u> Friday
12-	Shall delivery <b>Final List</b> of voters to contesting candidate.	=	<u>26-08-2011</u> Friday
13-	Any objection to nomination of candidate to be filed with Election Commission if any.....	=	<u>29-08-2011</u> Monday
14-	Decision by Election Commission on nomination objection.	=	<u>30-08-2011</u> Tuesday

15-	In case of Election Commission decision negative or otherwise, or any delay, the aggrieved candidate may file appeal with DIRECTOR GENERAL, T.O., if any.....	=	<u>05-09-2011</u> Monday
16-	<b>Final Decision</b> by Director General T.O. on nomination objection by aggrieved candidates.	=	<u>09-09-2011</u> Friday
17-	<b>Final List of contesting candidates</b> after decision of Director General, T.O. to be exhibited on notice board – website.	=	<u>10-09-2011</u> Saturday
18-	<b>Withdrawal</b> of candidature may be done by notifying in writing to Election Commission.	=	<u>12-09-2011</u> Monday
19-	After considering withdrawal or otherwise, if the members of validly nominated <b>candidate be equal to the vacant posts</b> , the Election Commission on the report of Polling Officer ( <b>Election Commission</b> ) will declare provisionally such candidates to <b>have been elected unanimously/ unopposed.</b>	=	<u>12-09-2011</u> Monday
20-	Contesting candidate <b>may appoint a Polling Agent</b> each by delivering a letter of appointment to the Election Commission.	=	<u>15-09-2011</u> Thursday
21-	Polling of votes shall be conducted in Association Registered Office from 9.00 A.M. to 4.00 P.M. without break to elect members of Executive Committee by Corporate and Associate Members.	=	<u>15-09-2011</u> Thursday
22-	Counting of votes shall take place immediately after the polling hours under the supervision of Polling Officer ( <b>Election Commission</b> ) and in the presence of the desiring candidates and / or their Polling Agent if any at the designated site.	=	<u>15-09-2011</u> Thursday
23-	Provisional results may be declared by the <b>Election Commission</b> immediately after the counting of votes is completed.	=	<u>15-09-2011</u> Thursday
24-	The <b>Election Commission</b> shall communicate in writing the result of election to the successful candidates and a copy thereof will be provided to the Secretary General.	=	<u>16-09-2011</u> Friday
25-	The Secretary General will convene the first Meeting within Two days of newly elected Members of the Executive Committee for Election of the Office Bearers.	=	<u>16-09-2011</u> Friday
26-	The <b>First Meeting of newly Elected Executive Members</b> will be held at 03:00 P.M. at Association Office for the election of following office Bearer.
